Subject: Appointment to the Indian Defence Accounts Service-CSE 2021.

On the basis of results of the Civil Services Examination 2021, you have been selected for appointment to the Central Services Group 'A' and allocated to the Indian Defence Accounts Service. Accordingly, the President is pleased to offer you an appointment to the Indian Defence Accounts Service ('IDAS' in short) on the following terms:-

- (a) You will be governed by IDAS Rules, 2021 (copy enclosed).
- (b) You will be subject to rules and regulations as applicable to the Central Government Employees of Group 'A' Service, including discipline etc.
- (c) You will be required to take an oath of allegiance to the Constitution of India (or make affirmation to that effect) as per prescribed form (enclosed).
- (d) You will be initially on probation for a period of two years, during which you will have to qualify for confirmation by passing the prescribed Departmental Examination and other courses of training and instruction. This period may be extended by the Government up to a total of four years, if considered necessary. Repeated failure to pass the probation (including extension thereof) will result in termination of your services. Extension of probation beyond the normal period of two years may entail loss of seniority. Further, if during the period of probation, you are held to be unsuitable in any manner for employment in the Indian Defence Accounts Service, your services may be terminated by the Government without notice.
- (e) The Pay admissible to you will be at level 10 of pay matrix of 7th Central Pay Commission.
- (f) In respect of pensionary benefits, you will be governed by the National Pension Scheme operative with effect from 01.01.2004.

- (g) Your acceptance of this appointment to the Indian Defence Accounts Service involves a definite liability for field service in or out of India as well as for service in any part of the country, for which you will be required to furnish a declaration in prescribed form (enclosed).
- 2. Since you have already reported for training at Lal Bahadur Shastri National Academy of Administration, Mussoorie on 29.08.2022, your appointment to the Indian Defence Accounts Service will take effect from the same date. You may, therefore, forward the attached declaration, duly completed, accepting liability for general and field service anywhere in or out of India. Two responsible persons should attest the declaration. However, you should clearly note that your appointment is subject to any change in the constitution of Indian Defence Accounts Service, which the Government of India may think it proper to make and that you would have no claim for any compensation in consequence of such change.
- 3. Consequent upon your relief from LBSNAA, Mussoorie on 09.12.2022, You are directed to immediately report to O/o the CDA (Trg.) & Director National Academy of Defence Financial Management (NADFM), Golibar Maidan, Pune (Ph. Nos. 020-26443851, 26444318, 26454510, 26401313) and attend the Induction Programme to be held from 12.12.2022 before being nominated to attend the Professional Training Course at National Institute of Financial Management, Sector-48, Pali Road, National Capital Region, Faridabad-121001.
- 4. If you are willing to accept this offer of appointment on the above terms and conditions and intend to join the Indian Defence Accounts Service, you should inform this office in writing immediately but not later than 12.12.2022 and also forward the duly completed, accepting liability for general and field service anywhere in or out of India. Two responsible persons should attest the declaration. Your failure to accept the offer of appointment by the prescribed date is liable to result in cancellation of the offer.
- 5. In pursuance of DoP&T OM No. T-21021/22/2019-Academy Desk dated 29.07.2019 on the Weightage of Combined Foundation Course and other Professional Trainings in fixation of relative seniority of IDAS (Probationers), the following are also submitted for kind information:
 - (a) Foundation Course is henceforth mandatory for the IDAS officers recruited through Civil Services Examination.
 - (b) The inter-se seniority among the Probationers recruited on the basis of results of Civil Services Examination conducted by the Commission in any year to the posts in the Junior Time Scale shall be fixed in accordance with the rules and orders on the subject, issued from time to time. The persons with higher total marks in all the examinations shall rank above person with lesser total marks.
 - (c) Once an officer trainees of any service undergoes Foundation Course, he/she would be required to repeat Foundation Course, if his/her service is changed. The marks obtained in the FC will be accepted by the CCA of the new service.

6. You may note that since the report regarding verification of your character and antecedents is still awaited, your appointment to the Indian Defence Accounts Service is <u>'Provisional'</u>, which shall be governed by the following conditions:

- (a) In case the enquiry as envisaged under Rule 20 of Civil Services Examination Rules is pending in your case, your appointment to the service will be subject to you being found suitable on the basis of such enquiry as may be considered necessary by the Government having regard to your character and antecedents.
- (b) In case, at any stage, it is found that any certificate/Document/Testimonial, etc. furnished by you and having a bearing on your eligibility is not in order or any information/material facts having bearing on your eligibility have been hidden/misrepresented by you, then your appointment is liable to be cancelled forthwith without prejudice to any other punitive action under relevant rules.
- 7. Further, you will be entitled for obtaining leave as per "short Term" leave policy as under:
 - (a) IDAS probationer can be granted 90 days EOL which will be renewed quarterly for a one year duration and thus making it a total of one year.
 - (b) The leaves can be granted by the Director, NADFM, as per FRSR.
 - (c) It's mandatory to avail all the 04 spells of EOL of 03 months each if he/she fails to qualify for the mains Examination. That means, a probationer after availing first quarter of EOL cannot join for departmental training in between.
 - (d) The leave will be granted at the time of joining the Department and NOC shall not be given for giving exam during training.

(e) Absence from department training due to availing EOL will not affect their inter-se batch seniority.

- 2. The Foundation Course is an important component of the probationary training and is common to IAS/ IPS and Group 'A' Services, recruitment to which has been made on the basis of the Civil Services Examination (CSE). Instructions regarding next Foundation Course would be intimated to you separately by Training Division of this Department. Nodal Officer for Foundation Course is Shri A.N. The formal offer of appointment will be sent to you by the respective Cadre Controlling Authority (CCA) of the service concerned, namely, Ministry of Defence (Finance), [Shri Sanjay Wadhawan, DS], Office of CGDA, Ulan Batar Road, Palam, Delhi Cantt-110010 (Ph.011-25665566, 25665701) in your case subject to verification of character and antecedents as well as claim(s) for reservation under EWS/ OBC/SC/ST/ PwBD (wherever applicable as per the extant rules). The Cadre Controlling Authority concerned will also take necessary action for verification of the same at

their own level. 4. The candidates must note that in case, at any stage, if it is found that the candidate's certificate is fake, or he has furnished false information during the course of the CSE, he shall be liable to be proceeded against under the relevant acts/ rules leading to such penalty as may be decided which now extends to termination of his appointment.

action shall also be without prejudice to any other punitive action as may be attracted in such cases.

In respect of the candidates allocated to any of the Central Civil Services, attention is invited to this Department's OM No. 11012/7/91-Estt.(A) dated 19.05.1993 as amended from time to time and which already stipulated the action that can follow furnishing of false information or submission of false/ fabricated certificates. The operative part of the said OM is reproduced as below:

"Wherever it is found that a candidate who was not qualified or eligible in terms of the recruitment rules etc., for initial recruitment in service or had furnished false information or produced a false certificate in order to secure appointment, he should not be retained in service. If, he is probationer or a temporary Government servant, he should be discharged, or his services should be terminated. If he has become a permanent Government servant, an enquiry as prescribed in Rule 14 of CCS(CCA) Rules, 1965 may be held and if the charges are proved, the Government servant should be removed or dismissed from service. In no circumstances should any other penalty be imposed."

The aforementioned OM dated 19.05.1993 clearly brings out that disciplinary enquiry involving the matter of securing dobs on the basis of false/fake certificates should be completed in a time bound manner and unscrupulous persons who have got appointment on the basis of fake/false certificates should not be retained in service and should be dismissed/removed from service.

- 6. This allocation of service is provisional for the candidates who have claimed/availed the benefits of any type of reservation for posts and service in terms of the following instructions.
 - (i) OBC/ SC/ST/ PwBD Candidates: This Department's OM No 11012/7/91-Estt.(A) dated 19.05.1993 as well as other extant instructions in this regard issued from time to time. The allocation is, therefore provisional to this extent and is subject to due verification of OBC/ SC/ST/ PwBD certificate by the Cadre Controlling Authority.
 - (ii) EWS candidates:This Department's OM No No.36039/1/2019-Estt (Res) dated 31.01.2019 as well as other extant instructions in this regard issued from time to time. The allocation is, therefore, provisional and is subject to the 'Income and Asset Certificate' being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate. Accordingly, the appointing authority shall verify the veracity of the 'Income and Asset Certificate' submitted by the candidate through the certificate issuing authority.
- 7. Please also note the following instructions:
 - a) If you do not report to respective Cadre Controlling Authority on before the scheduled date to be decided? fixed by the CCA, it will be presumed that you are not interested in joining the service on the basis of CSE 2021 and further action regarding cancelling your offer of appointment may be taken without any further notice.
 - b) In case, the enquiry as envisaged under Rule 23 of the Civil Services Examination Rules, 2021 is pending in your case, your appointment will be subject to your being found suitable on conclusion of such enquiry and consequent necessary decision by the Government with regard to your character and antecedents.
 - c) In case, at any stage, it is found that any Certificate/Document/Testimonial etc. as furnished by you and having a bearing on your eligibility is not in order, then your appointment shall be cancelled forthwith without prejudice to any punitive action under the relevant rules.
 - d) As a person having more than one spouse living is not eligible for appointment to Government service, your appointment, too, would be subject to this condition.
 - e) Further, the Government has implemented a new structured defined Contributory Pension scheme for new entrants to the All India Service/Central Civil Service w.e.f. 1st January 2004, replacing the earlier system of defined Benefit Pension System. Accordingly, wherever applicable, you will be joining the new contributory pension scheme instead of the earlier defined Benefit Pension System.


